

DEALER CONTRACT

This agreement is entered into between the Kitchener-Waterloo Philatelic Society (the “KWPS”) and _____ (the “Dealer”).

In consideration of the mutual covenants contained herein, the KWPS and the Dealer hereby agree as follows:

1. The KWPS shall host the annual convention of the Royal Philatelic Society of Canada (the “RPSC”) known as the Royal 2026 Royale to be held in Waterloo, Ontario at the Waterloo Memorial Recreation Complex, June 12-14, 2026 (the “Event”);
2. The Dealer shall complete and submit, by way of regular mail or email to the addresses hereinafter set out, a Bourse Application in the form attached hereto, specifying the bourse space (the “Designated Bourse Space”) and program advertising, if any, (the “Designated Program Advertising”) which the Dealer wishes to reserve in order to participate in the Event.
3. The Dealer, while in attendance at the Event and in possession of the Designated Bourse Space shall:
 - i) limit his/her business to the purchase, sale, or trade of philatelic and related supplies and equipment which the Dealer brings to the Event (the “Dealer’s Goods”);
 - ii) maintain the Designated Bourse Space, including but not limited to the Dealer’s Goods, in an orderly and presentable manner in keeping with the general scheme of the Event;
 - iii) be solely responsible for maintaining adequate property insurance coverage with respect to the Dealer’s Goods and for any loss incurred to the Dealer’s Goods;
 - iv) obtain, prior to and to maintain for the duration of the Event, all provincial and/or municipal permits and licences as required by law and shall be solely responsible for any non-compliance therewith;
 - v) provide the full name(s) of the individual(s) working with the Dealer at the Designated Booth Space (the “Designated Dealer Personnel”);
 - vi) save harmless the KWPS, the RPSC, the City of Waterloo and their respective officers, directors, members, employees, successors or assigns, as the case may be, from any liability for any personal injury to any of Designated Dealer Personnel or for loss or damage to the Dealer's Goods for any reason or from any cause whatsoever;
 - vii) be bound by the hours of operation and regulations of the Event established by the KWPS.
4. If the Dealer wishes to share the Designated Bourse Space with another Dealer, such an arrangement must be specified in the attached Bourse Application and receive the prior written approval of the KWPS..
5. Each Bourse Application shall be followed within 14 days of acceptance by the KWPS by a deposit payment equal to 50% of the Booth Fee and 100% of the Advertising Cost as set out therein, payable by cheque or e-transfer. The KWPS reserves the right to reassign the Designated Bourse Space

to another dealer if full payment is not received by December 31, 2025. If written notice of cancellation from a Dealer is received by the KWPS on or before December 31, 2025, a refund of the Dealer's deposit will be made, but a deduction will be made for any expenses incurred by the KWPS in respect thereof.

6. The Dealer agrees that in the event that a contravention of any of the aforementioned terms, has occurred, as determined at the sole discretion of the KWPS, the Dealer shall immediately forfeit the Designated Bourse Space and his/her payment thereof to the KWPS. The Dealer may be evicted or banned from the Event if, in the sole discretion of the KWPS or of the R.P.S.C., his/her dealings are not of the highest order of honesty and fairness. Any conduct which, in the sole discretion of either the KWPS or the R.P.S.C., will bring disrepute upon the Event will be grounds for eviction with losses and costs to be borne by the Dealer.

7. The Dealer acknowledges having read and understood the terms of this Agreement.

8. Two copies of this agreement executed by the Dealer are to be sent to the address indicated on the Dealer Registration Form. If the application is accepted, both copies will be signed on behalf of the KWPS, and one fully executed copy will be returned to the Dealer.
